Objective and Investment Policy

The objective of this Sub-Fund is to track the performance of Markit iBoxx USD Liquid Emerging Markets Sovereigns Mid Price TCA Index (the "Index"), and to minimize the tracking error between the net asset value of the Sub-Fund and the performance of the Index. 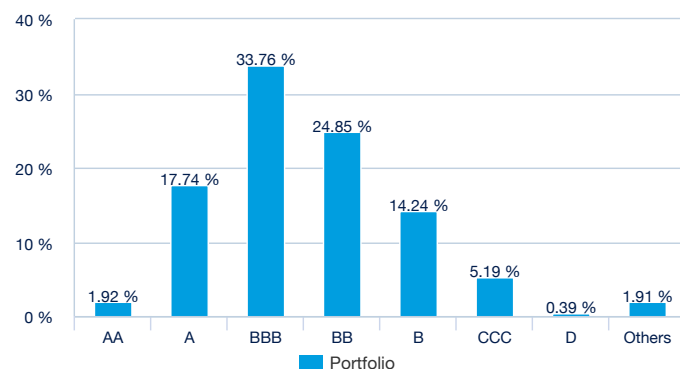

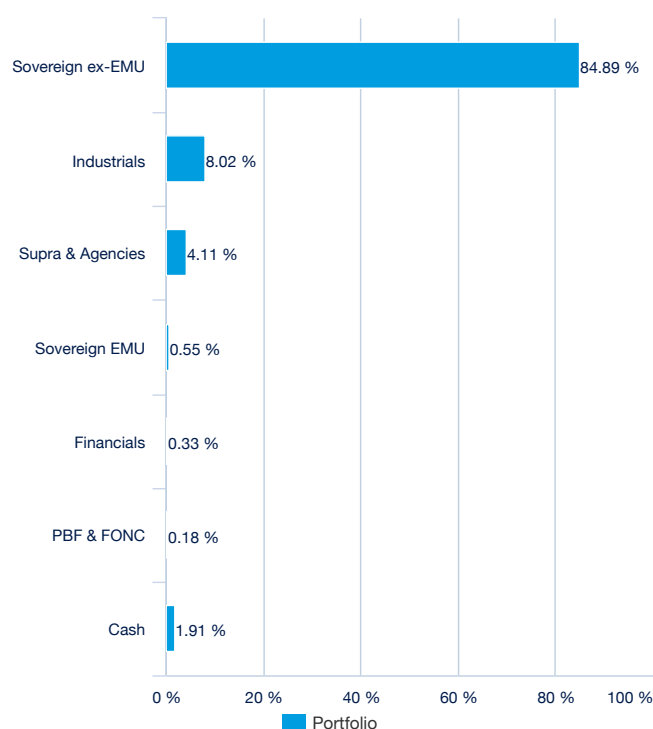
By maturity (Source: Amundi)



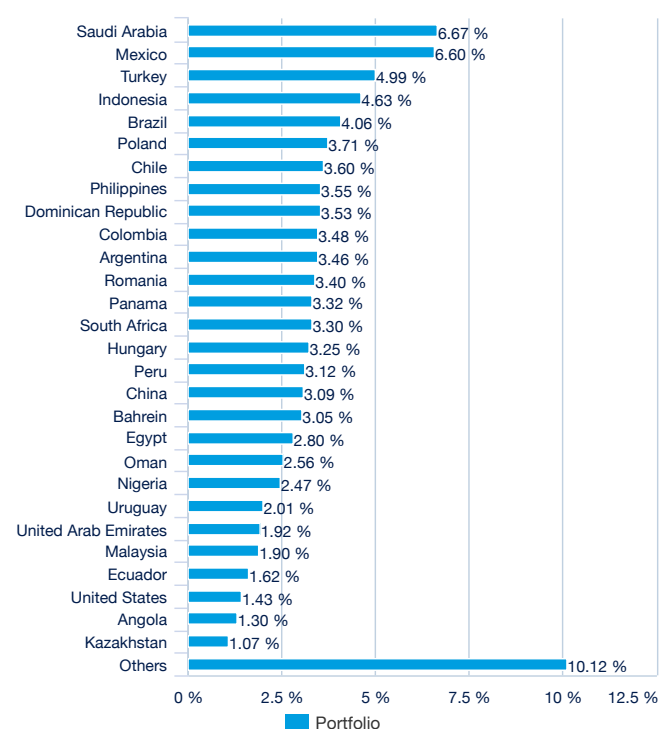
