Description of the Index

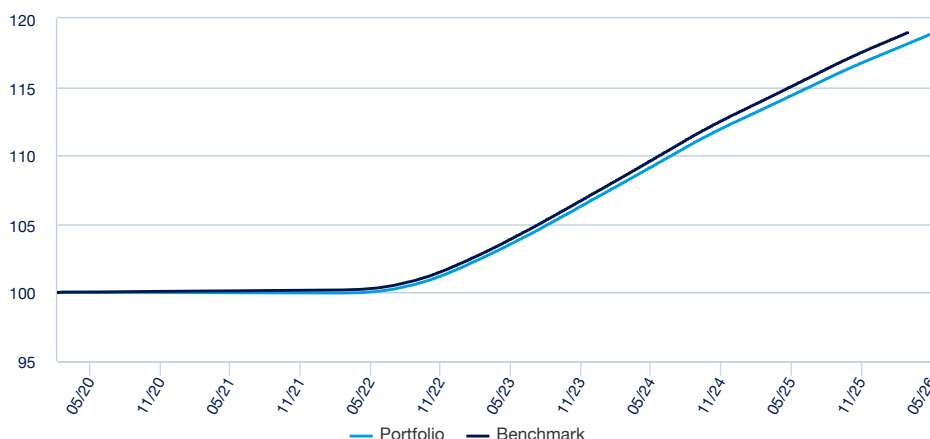
