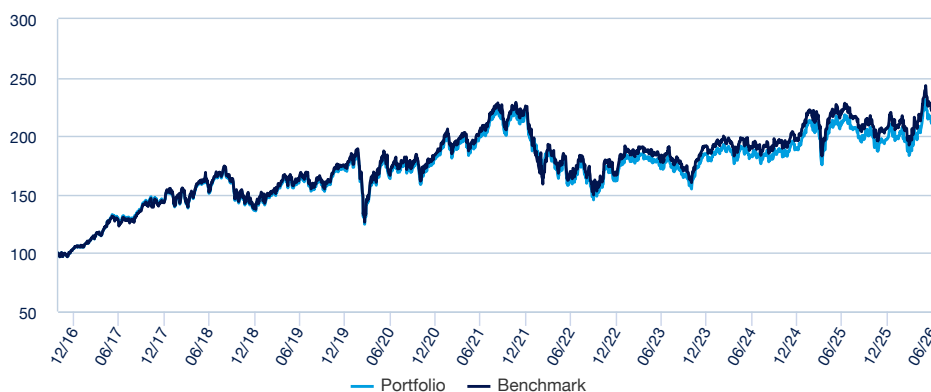

The TecDax® Total Return Index was first calculated on March 24th in 2003 based on 1000 points on December 30th 1997.

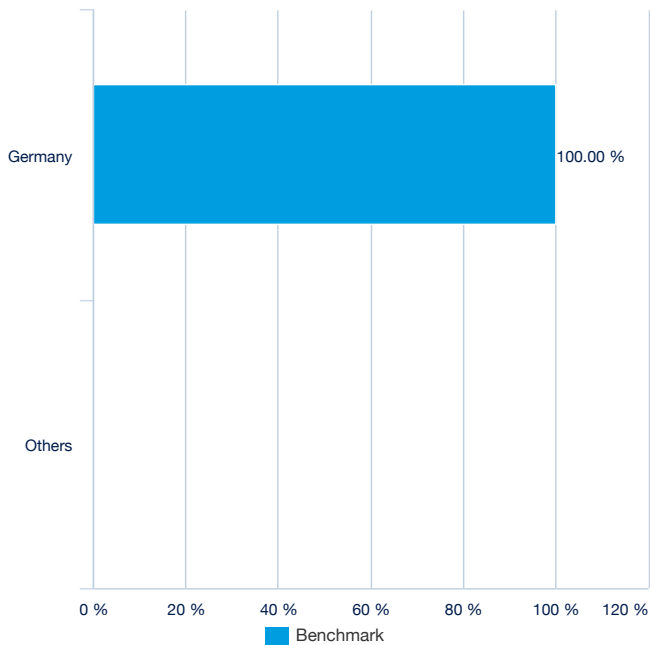

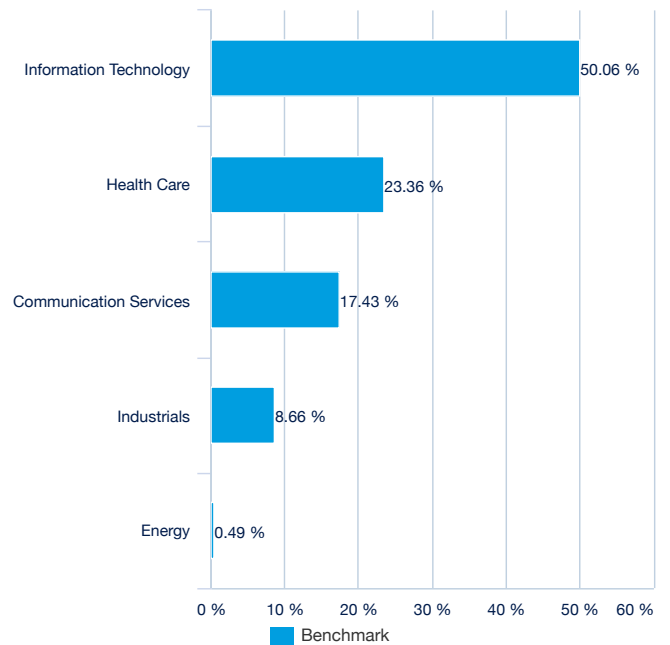
