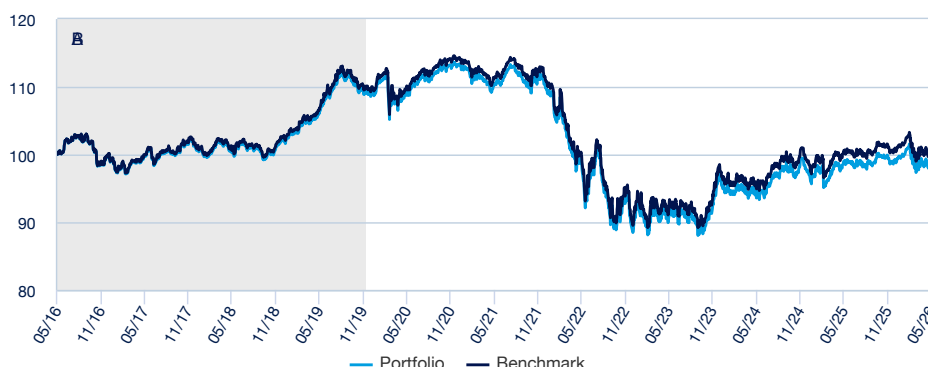

Eligible securities must have maturities of at least 7 years and no more than 10 years, with a minimum outstanding amount of €300m.

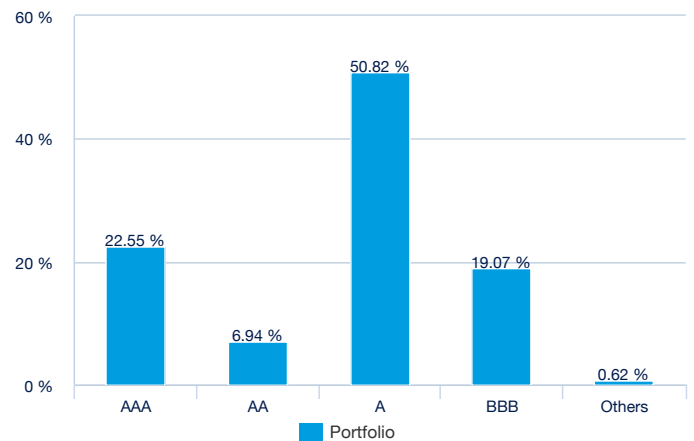

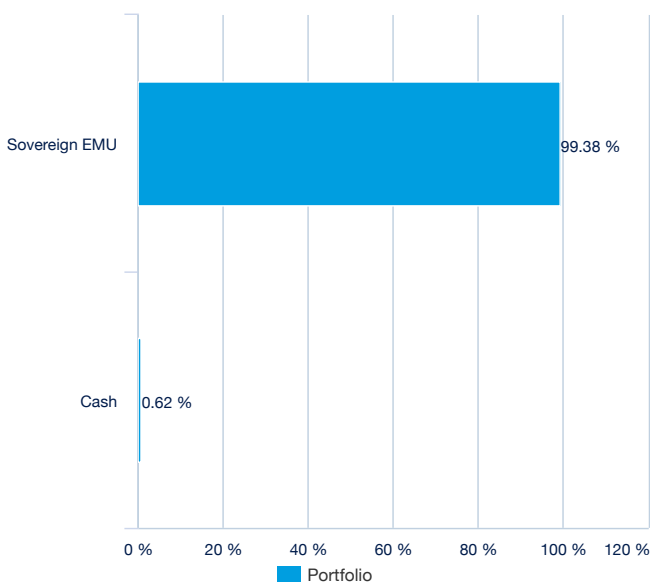
By maturity (Source: Amundi)



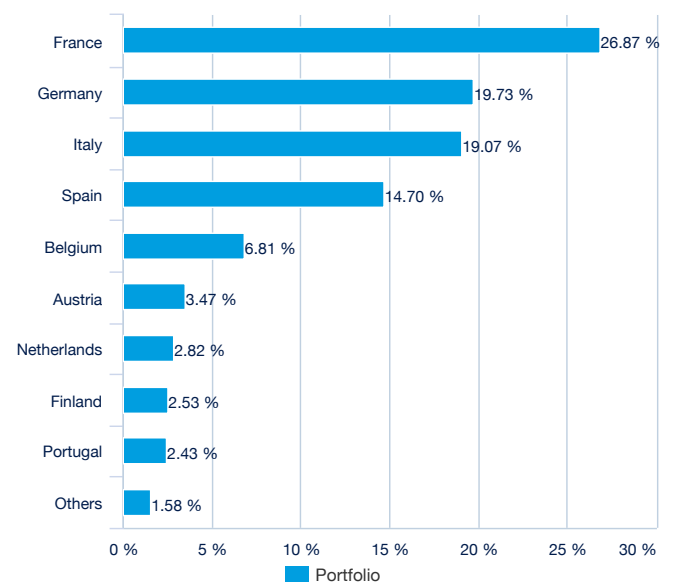
