Description of the Index

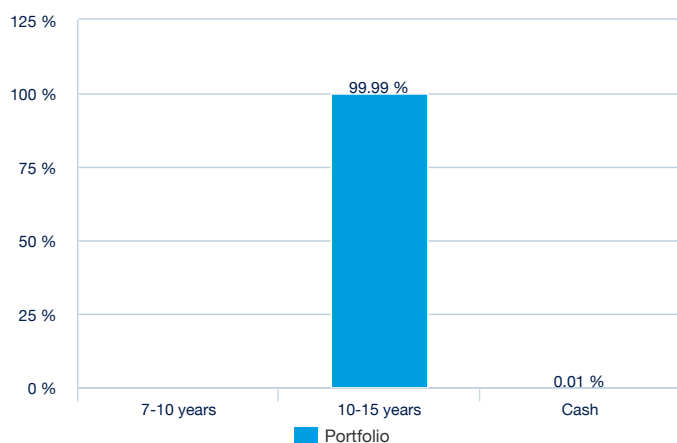

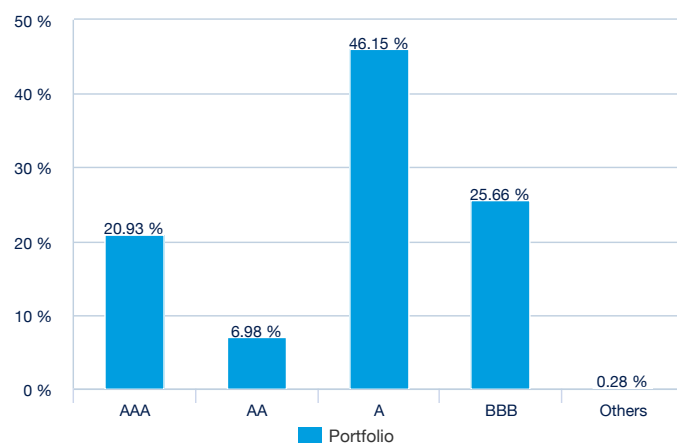

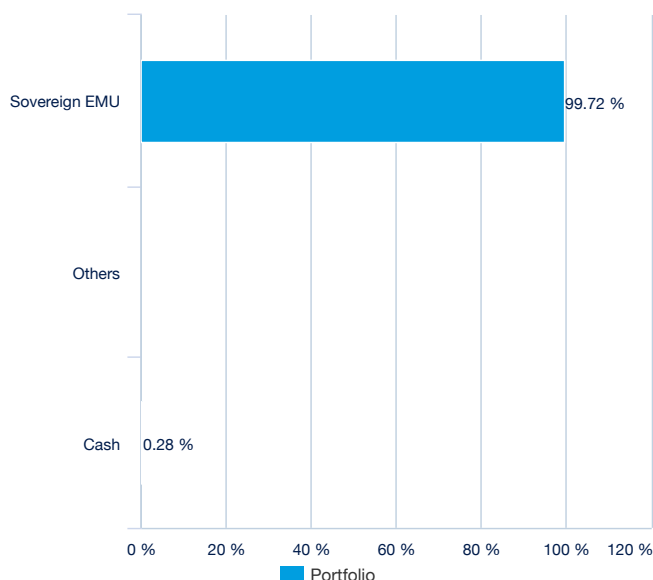

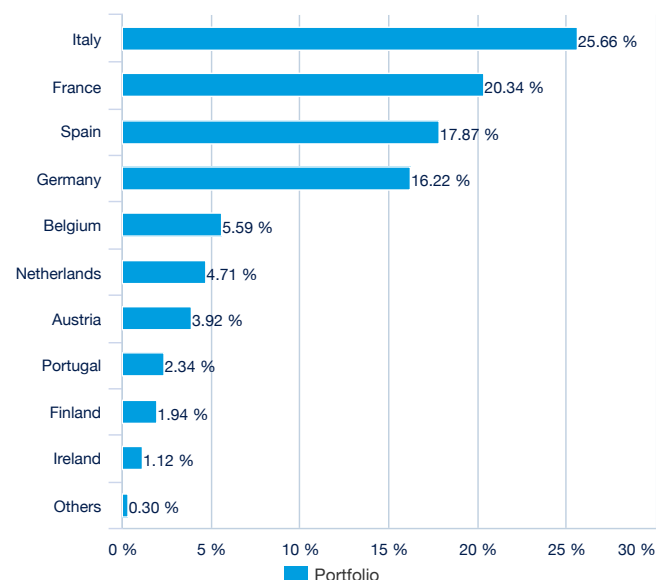
