The Lyxor US Treasury 7-10Y (DR) UCITS ETF - Monthly Hedged to HKD - Acc is a UCITS compliant exchange traded fund that aims to track the Bloomberg Barclays U.S. Treasury 7-10 Year TR Index. The HKD-hedged share class offers the simplicity of a monthly currency hedge mechanism that is embedded in the investment product, representing an efficient solution to manage the foreign-exchange risk.

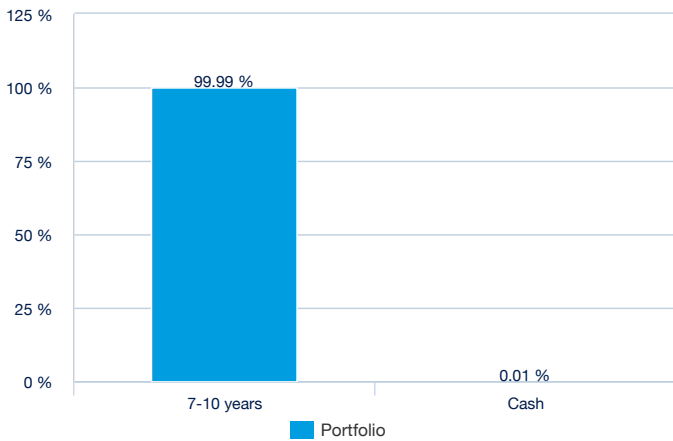

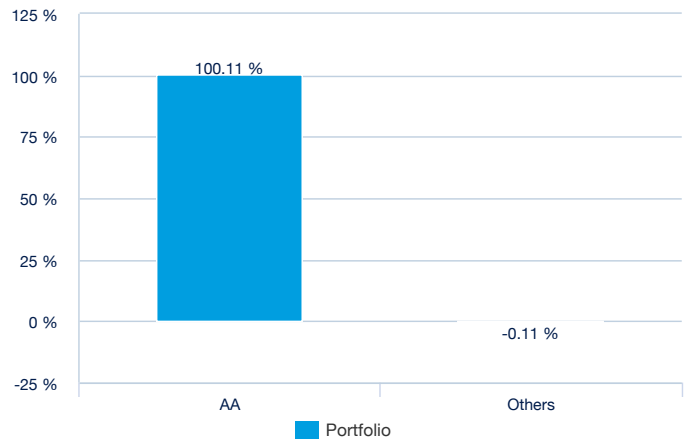

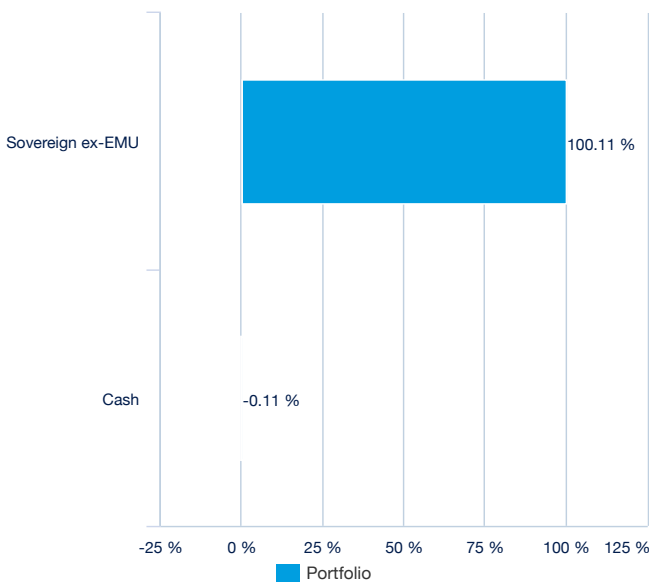
By maturity (Source: Amundi)



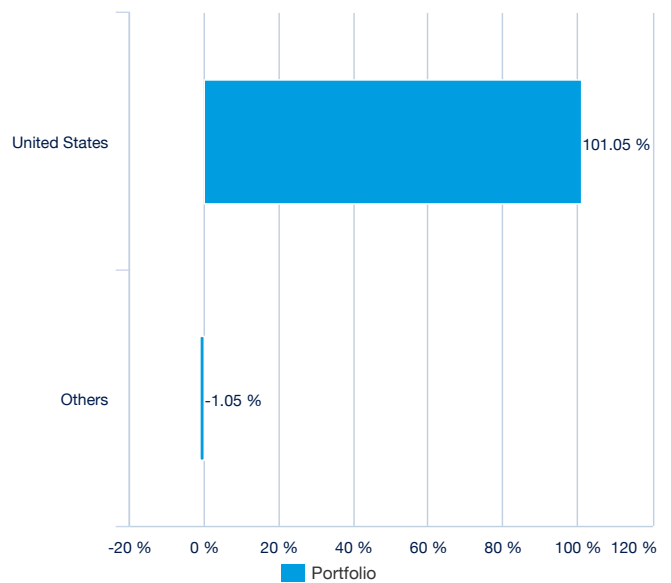
