KEY INFORMATION DOCUMENT

What is this product?

Type: Shares of a Sub-Fund of Lyxor Index Fund, an Undertaking for Collective Investments in Transferable Securities (UCITS), established as a SICAV.

Term: The term of the Sub-Fund is unlimited. The Management Company may terminate the fund by liquidation or merger with another fund in accordance with legal requirements.

Objectives: The investment objective the Fund is to track both the upward and the downward evolution of the MSCI World Select Catholic Principles ESG Universal and Environment Net Total Return Index (the "Benchmark Index") denominated in USD, while minimizing the volatility of the difference between the return of the Fund and the return of the Benchmark Index (the Tracking Error").

The anticipated level of Tracking Error in normal market conditions is indicated in the prospectus.

The Benchmark Index is an equity index calculated and published by the international index provider MSCI, which features the following characteristics:

1) Same investment universe of securities as the MSCI World Index (The "Parent Index"),

2)Exclusion of companies with an MSCI ESG Rating stritly below "BB", involved in controversial businesses, and with a very serious ESG controversy.

3)Exclusion of companies that are involved in Stem Cells, Abortions and Contraceptives and Animal Welfare,

4)Exclusions of TOP 20% securities by carbon emission intensity and reduction of potential carbon emissions from fossil fuel reserves by 50%,

5)Weighting by the product of companies' free-float market cap weights in the Parent Index and a Combined ESG Score reflecting an assessment of both the current ESG profile as well as the trend in that profile.

The prospectus describes limitations of the methodology of the Benchmark Index through risk factors such as risk related to the carbon data used in methodology of the Benchmark Index or lack of reactivity to ESG fundamentals changing circumstances, or Extra Financial risks related to the components of the Benchmark Index.

information about the MSCI indexes.

The Benchmark Index is a net total return index. A net total return index calculates the performance of the index constituents on the basis that any dividends or distributions are included in the index returns after withholding tax retention.

The Fund seeks to achieve its objective via a direct replication, by investing primarily in the securities comprising the Benchmark Index. To optimize the Benchmark Index replication, the Fund may use a sampling replication strategy. The potential use of this technique is published on Lyxor's website: www.lyxoretf.com.

In addition, the indicative net asset value is published on the Reuters and Bloomberg pages of the Fund, and might also be mentioned on the websites of the stock exchanges where the Fund is listed.

Intended Retail Investor: This product is intended for investors, with a basic knowledge of and no or limited experience of investing in funds and who are prepared to take on a high level of risk to their original capital.

Redemption and Dealing: The Sub-Fund's shares are listed and traded on one or more stock exchanges. In normal circumstances, you may deal in shares during the trading hours of the stock exchanges. Only authorised participants (e.g., selected financial institutions) may deal in shares directly with the Sub-Fund on the primary market. Further details are provided in the Lyxor Index Fund prospectus.

Distribution policy: As this is a non-distributing share class, investment income is reinvested. the accumulation share automatically retains, and reinvests, all attributable income within the Sub-Fund; thereby accumulating value in the price of the accumulation shares.

What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movement in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

What happens if Amundi Asset Management is unable to pay out?

The Sub-Fund would not be liable if the Management Company or any delegated service provider were to fail or default.

What are the costs?

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
- USD 10,000 is invested.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years is based on our assessment of the risk and reward characteristics and costs of the Sub-Fund.

This product is designed for medium-term investment; you should be prepared to stay invested for at least 5 years. You can redeem your investment at any time, or hold the investment longer.

Order schedule: Orders to redeem shares must be received before 06:30 PM Luxembourg time no later than one (1) Business Day before the Valuation Day. Please refer to the Lyxor Index Fund Prospectus for further details regarding redemptions.
