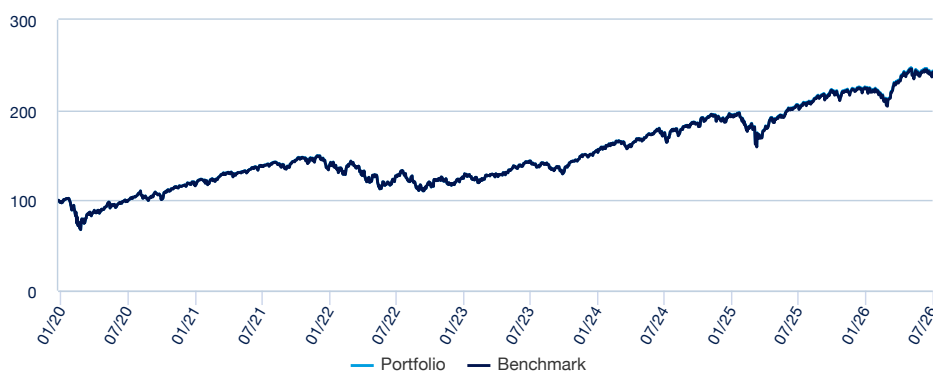

Objective and Investment Policy

The objective of this Sub-Fund is to track the performance of the MSCI Daily TR Net USA (the "Index"). The Sub-Fund aims to achieve a level of tracking error of the Sub-Fund and its index that will not normally exceed 1%.

Description of the Index

The objective of this Sub-Fund is to track the performance of the MSCI USA Index (the "Index"). The Index is an equity index representative of the large and mid-cap listed securities of the US equity market. The Index is a Net Total Return Index: dividends net of tax paid by the index constituents are included in the Index return. 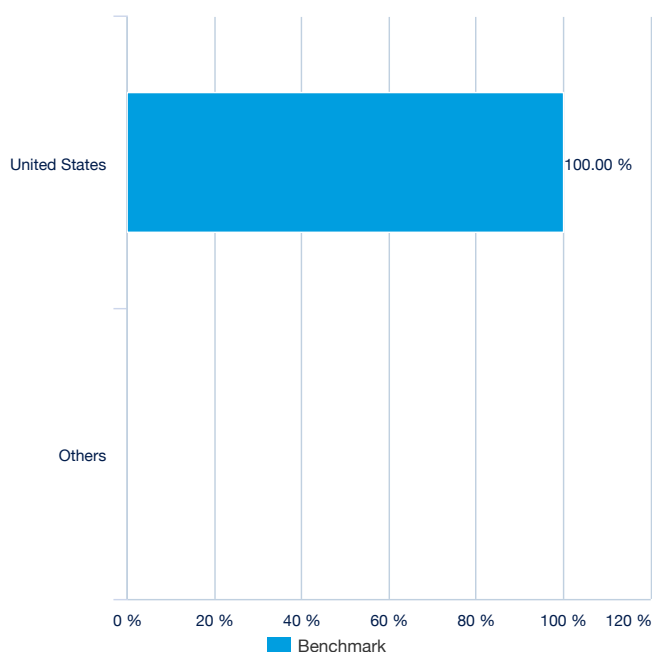

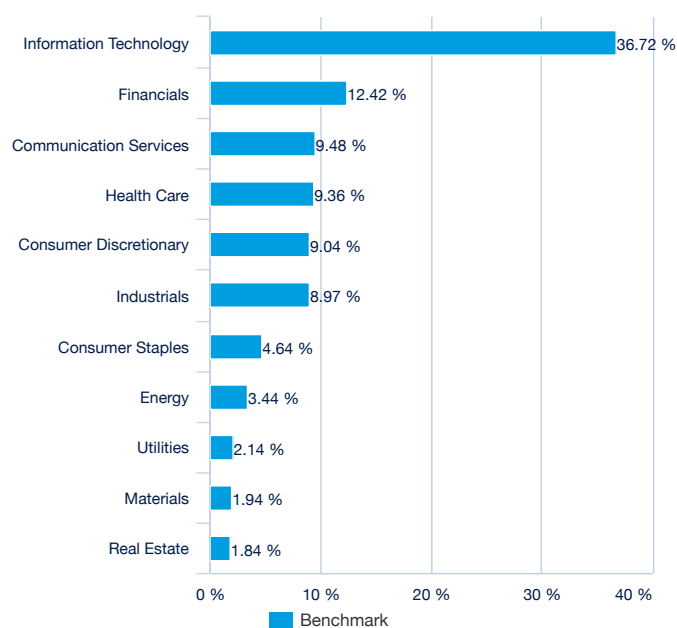
