Description of the Index

Eligible securities must have maturities of at least 1 year and no more than 3 years, with a minimum outstanding amount of €300m.

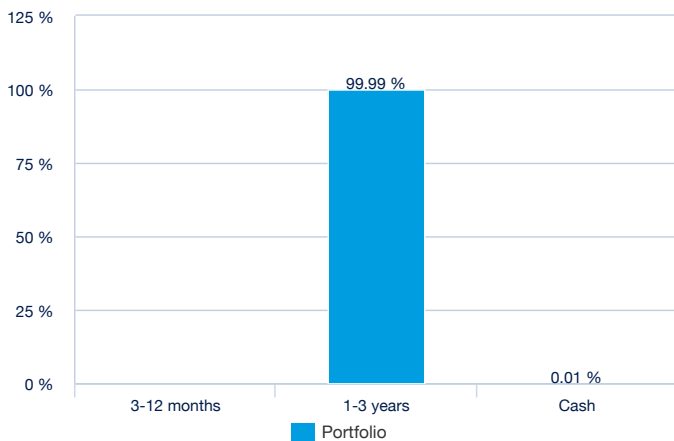

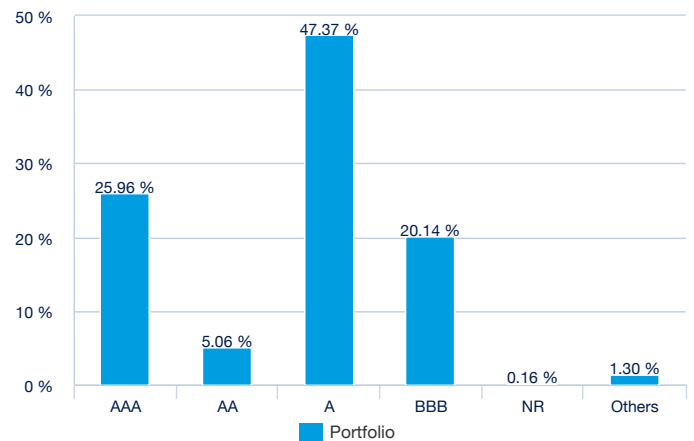

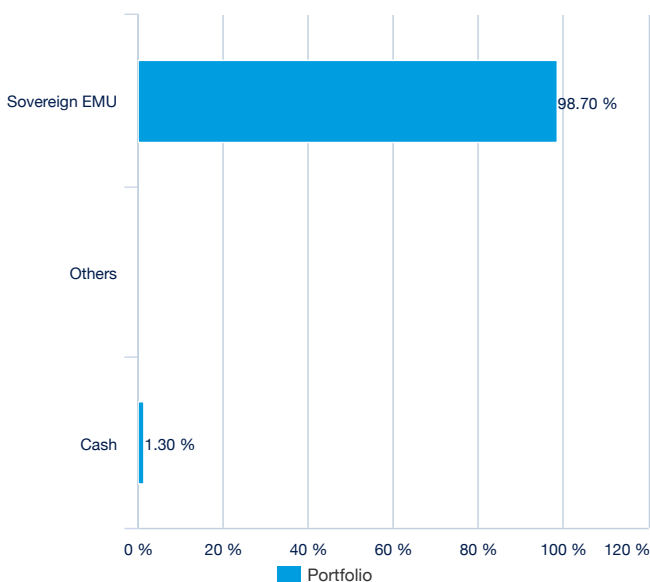
By maturity (Source: Amundi)



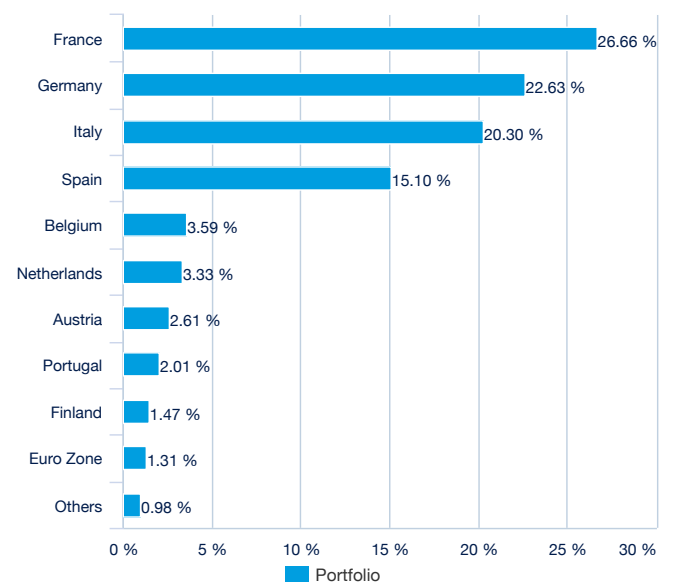
