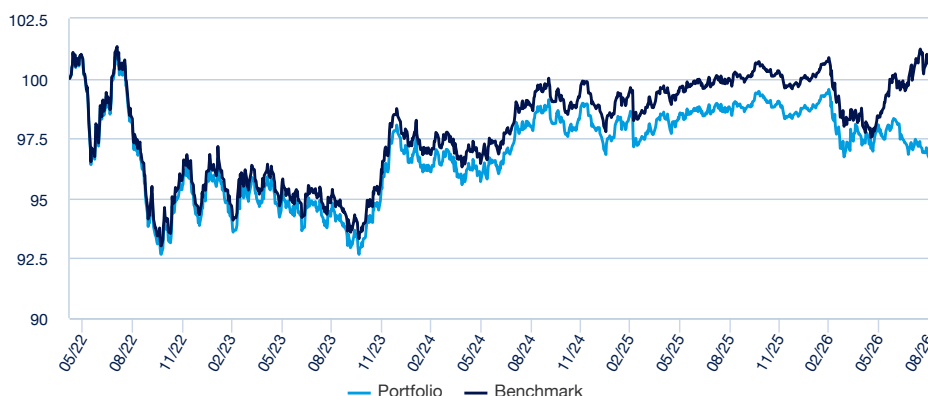

Objective and Investment Policy

The Amundi Global Green Bond 1-10Y (DR) UCITS ETF is an ETF (exchange traded fund) compliant with the UCITS Directive. Its objective is to replicate, upwards and downwards, the Bloomberg MSCI Global Green Bond 1-10 Year Index. The CHF hedged share class offers the simplicity of a monthly currency hedging mechanism, integrated into the investment product, to manage currency risk.

Description of the Index

The Benchmark Index is representative of the performance of Green Bonds issued by investment grade entities and denominated in multiple currencies. Green Bonds are issued in order to fund projects that have positive environmental outcomes. To be eligible in the Benchmark Index, Green Bonds are independently evaluated by MSCI ESG Research along four dimensions to determine whether they should be classified as green bond: stated use of proceeds, process for green project evaluation and selection, process for management of proceeds, commitment to ongoing reporting of the environmental performance of the use of proceeds. 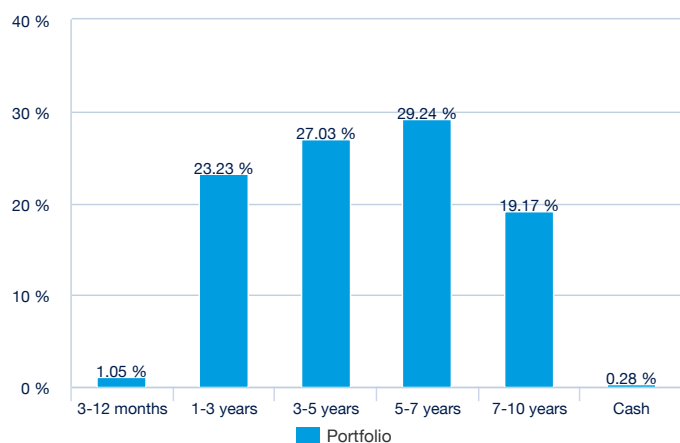

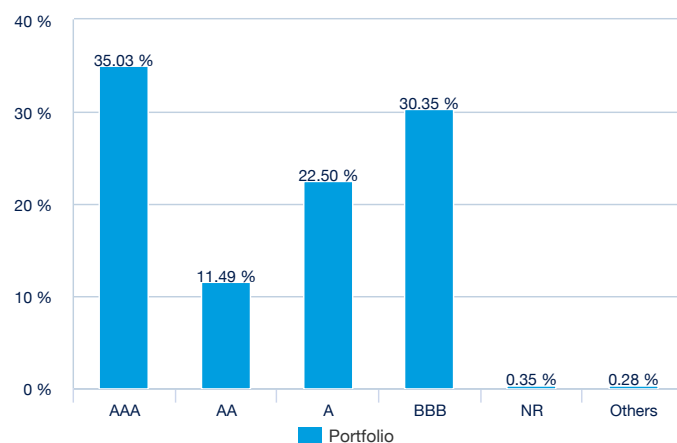

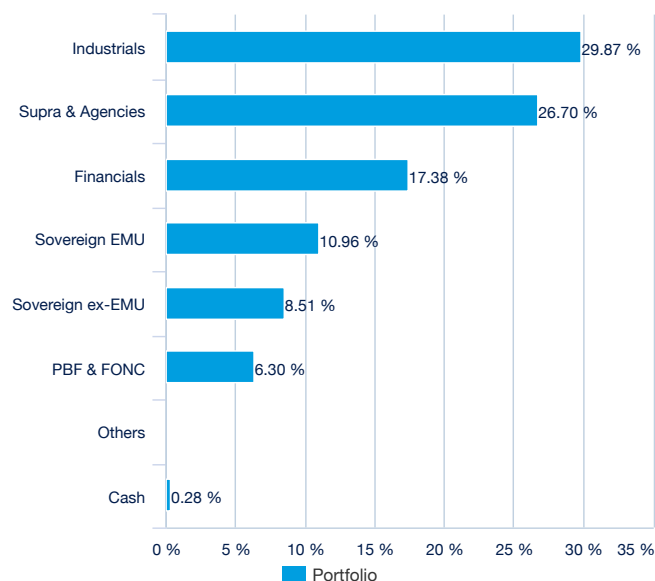
By maturity (Source: Amundi)



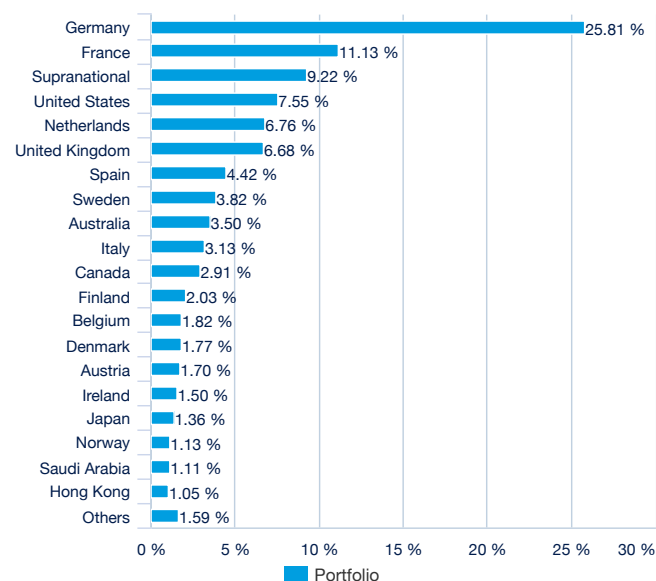
