The transfer of the custodian function from BNP Paribas Securities Services S.C.A., Frankfurt Branch to BNP Paribas S.A., Germany Branch, equipped with a corresponding European passport, is a case of universal succession in which all custodian functions already approved are retained.

The German Federal Financial Supervisory Authority (BaFin) has been informed of the change of custodian.

The investors will not incur any costs from the change of the custodian.
